Ms Ruttiman reported that West Virginia was a "right to work state" which was the American government's term for breaking the power of unions. This action supported the strength of activism, the right to bargain and join together to strike and to force the legislature to recognise unions. Ms Ruttiman spoke regarding students leading a movement in Florida to cease gun violence in schools following the Valentine's Day shooting in Parkland, Florida. Ms Ruttiman stated that the student action was admirable but students should not be forced to take action to ensure their schools were safe.

THAT this meeting of QTU State Council reaffirms its support for previous State Council resolutions on Palestine and particularly support for the Boycott, Divestment, Sanctions (BDS) campaign which is the Palestinian-led movement for freedom, justice and equality.

Mr P Monsour moved, Mr G Moloney seconded:

In line with the policy of State Council, the Queensland Teachers' Union commits to respect the Palestinian picket line and honours the call for Boycott, Divestment, Sanctions (BDS) to uphold the simple principle that Palestinians are entitled to the same rights as the rest of humanity. Focusing on the key international campaigns that target companies who are complicit in the ongoing occupation and colonisation of Palestine, such as the global corporate giants Caterpillar, G4S, and Hewlett Packard.

Mr P Monsour explained the circumstances behind the motions including the arrest and detention of a 16 year old Palestinian girl late last year. Mr Monsour referred to the campaign by over 170 civil society organisations calling for similar principles to the international boycott of apartheid in South Africa involving academic, cultural and economic sanctions. The third motion was a practical activity which could easily and simply provide support for the boycott. Mr Monsour stated that these motions were not despite the many terrible situations in other countries, including Australia, but were linked and assisted by gaining strength and solidarity internationally as well as locally for human rights.

Mr G Moloney spoke in support of the motion.
